Special and/or sensitive personal data that we process

For what purpose and based on what basis we process your personal data

Nicole Siers processes your data for the following purposes:

- Handling of your payment
- Sending our newsletter and/or advertising folder
- To call or email if this is necessary in order to perform our services
- To inform you of changes to our services and products
- To deliver goods and services to you
- Nicole Siers also processes personal data if we are required by law, such as data that we need for our tax return.

Automated decision making

Nicole Siers does not take decisions on matters based on automated processing that may have an (considerable) impact on people. We are talking about decisions taken by computer programs or systems, without a human being (for example, an employee of Nicole Siers) in between.

How long we store personal data

Nicole Siers no longer stores your personal data than is strictly necessary to the goals for which your information is collected. We apply the following retention periods for the following (categories) of personal data:

Sharing of personal data with third parties

Nicole Siers does not sell your information to third parties and will only provide it if needed for the implementation of our agreement with you or to comply with a legal obligation. With companies that process your data on our behalf, we enter into a contract processors to ensure the same level of security and confidentiality of your data. Nicole Siers remains responsible for this processing.

Cookies, or similar techniques, which we use

Nicole Siers does not use cookies or similar techniques.

Look into Information, modify or delete

You have the right to look into, modify or delete your personal data, correct or delete them. In addition, you have the right to pull back any permission for the data processing or to object to the processing of your personal data by Nicole Siers and you have the right to data portability. That means that you can apply to the personally identifiable information of yours we have in to send a computer file to you or another organization, mentioned by you.

You can do a request for inspection, correction, removal, data transfer of your personal information or ask to withdraw your consent or object to the processing of your personal data, send it to nicole@nicolesiers.com.

To ensure that the request for inspection is done by you, we will ask you a copy of your ID with the request. In this copy, black out your passport photo, MRZ (machine readable zone, the Strip with numbers at the bottom of the Passport), passport number and social security number (BSN). This to protect your privacy. We respond as quickly as possible, but at your request, within four weeks.
